The tasks of the Bank of Sweden Tercentenary Foundation

According to its statutes, the objective of the Foundation is to support and promote scientific research related to Sweden. This means that a) precedence is given to research fields which are not adequately financed in other ways, b) Foundation grants are primarily made to major, long-term projects, c) special support is provided for new research fields demanding rapid and comprehensive measures and d) contacts with international research activities are promoted.

The guidelines drawn up prior to the Riksdagen's adoption of the Foundation statutes prescribed that the activities of Foundation initially "concentrate on research aimed at expanding knowledge about the impact of technical, economic and social changes on the society and on individual citizens".

The statutes call for considerable flexibility in Foundation programmes. In principle, no field of research is to be excluded from the possibility of receiving a Foundation grant.

Thus, the Board of Directors feels that socially important fields of research which lack any particular representatives should also receive special support. In this manner, Foundation resources can be viewed primarily as a *complement*, not as an alternative, to resources already available for financing research in Sweden.

Procedure

The Board of Directors had four formal meetings during the year. In most cases, applications for grants are vetted by special experts prior to consideration by the Board. Applications are also reviewed and assessed by one or more committees (priority assignment committees) before being ruled on by the Board. The committees consist of Board members and experts outside the Board. At the end of 1983, the five committees appointed by the Board were composed of the following members:

Finances

The Foundation's economic position on 31st December 1983 and 1982 is described in tables below. A few minor changes, compared to the tables from previous years, should be noted.

The item Bequests under Liabilities in the BALANCE SHEET consists of two sub-items; "Capital" and "Valuation difference, bequest capital". "Capital" consists of securities listed at the book values recorded for them at the time of their transfer to the Foundation (1962, 1974 and 1978). "Valuation difference, bequest capital" constitutes the difference between the face value of the securities portfolio and the previous book value of those securities. This item declined by 510 000 Swedish crowns during the year.

The decline corresponds to the cost incurred when low-yield securities were replaced with high-yield securities. Low-yield securities are then often sold at prices less than the face value. Transactions of this kind are carried out to increase the yield of a securities portfolio. From 1983 on, the result will also be listed in the APPROPRIATION ACCOUNT (Expenses, Sale and revaluation effects; and Revenue, brought forward from "Valuation difference, bequest capital").

The Assets side of the Balance Sheet comprises the Foundation's securities, listed, as before, at the face values. (A footnote also describes the contents and rate on 31st December.) This item declined by 370 000 Swedish crowns during the year. This decline was mainly due to the fact that some of the bonds were drawn, i.e. fell due for redemption.

The described changes in the Foundation's annual accounts were made after consulting the accounting department of the Bank of Sweden and the Accounting Office of the Riksdagen. The Board of Directors hopes that the accounts will be easier to follow than has been the case in previous years and give a clearer picture of the Foundation's economic position for the year.

Project grants

In 1983, the Foundation approved 229 research grants totalling 47.1 million Swedish crowns (Table 3, p. 24) plus 1 million Swedish crowns to cover automatic salary increases, travel expenses for ongoing projects and the work of the special committees. Other project costs amounted to 1.5 million Swedish crowns. Administrative costs (specified below) amounted to 2 million Swedish crowns.

A special section (p. 7–22) describes new research projects to which grants were awarded in 1983. Certain statistical information is also supplied (p. 24–25) on the applications considered. The 1979 Annual Report contained summaries of all the research projects, listed by subject, supported by Foundation grants up to that year.

Awarded grants are utilised according to special conditions specified in the contract with every grant recipient and according to the rules drawn up by the Foundation for grant recipients and grant administrators. Virtually every grant awarded by the Foundation is administered by some state-run school which then serves as the employer of the staff being paid with grant funds. The administration fee (1 million Swedish crowns) paid to shools in 1983 is listed in specifications for project costs (b 2).

28 % of the grant funds awarded in 1983 went to new projects. The corresponding percentages for the three preceding years were 33 %, 27 % and 22 % respectively.

The average of grants declined considerably in real terms. The average grant in 1979, 165 000 Swedish crowns, would have been equivalent to 248 000 Swedish crowns in 1983 if increased to reflect changes in the consumer price index. The average size of grants in 1983 was 206 000 Swedish crowns.

Assets

The Foundation's grant capacity is totally dependent on the yield from assets placed at the disposal of the Foundation by decree of the Swedish parliament. The assets consist of a securities portfolio (bonds) managed by the Bank of Sweden. The Foundation's cash assets also generate some interest revenue.

From 1968 to 1974, revenue amounted to 20 million Swedish crowns per annum. From 1975 to 1978, annual revenue rose to 27 million Swedish crowns, following an additional Riksdag appropriation of 100 million Swedish crowns in the spring of 1974. In 1979 and 1980 annual revenue amounted to 36 and 41 million Swedish crowns respectively. It rose to more than 50 million Swedish crowns a year from 1981. The 1979 increase was due to the increased capitalization (100 million Swedish crowns) granted by the Riksdagen in 1978. Subsequent increases were due to the redemption or sale of certain low-yield securities. Securities with a higher yield could then be purchased. Revenue increases of the latter kind are expected to be completely marginal in the next few years.

So there has been a *nominal* increase in the magnitude of Foundation grants in recent years. The increase was clearly less than changes in indices for general price trends in Sweden. However, research project costs have risen much more than

changes in the consumer price index suggest. Thus, it has not been possible to sustain the Foundation's award capacity in *real* terms. (If 1968 were used as the base year, the decline in award capacity would be found to be very considerable.)

The 1981 Annual Report provided a detailed account of Board deliberations on the Foundation's future role and finances. A study, carried out at the request of the Board of Governors of the Bank of Sweden for the purpose of creating a method "for better long-range allocation of Foundation award funds," was also described. One point of departure for the study and the Foundation's activities right from the start is the importance of the Foundation to Swedish research. Its "unique position as an interdisciplinary body and its unique links to the Riksdagen are unparalleled". So measures "to sustain its award capacity in years to come are essential". The Riksdagen, as reflected by a number of bills in recent years, shares the same view. The Board of Directors feels that the Foundation's importance to the generation of new knowledge in Sweden has increased even further.

To preserve the Foundation's present grant capacity in real terms, the Foundation will have to begin utilizing its grant reserves (listed in the BALANCE SHEET under Liabilities) in 1984. According to the assessments which can be made at this point, these reserves will be consumed in 4–5 years. A drastic decline in award capacity will then ensue if annual revenue is the only source of replenishment. The Board of Directors is anxious to emphasize the need for a decision method which will guarantee long-term preservation of the Foundation's present award capacity.

Project Follow-up

Many of the research projects supported by Foundation funds deal with problems of general social pertinence. The dissemination of research results for discussion and critical scrutiny is therefore important. That is why e.g. a number of meetings were held during the year at which certain projects were presented and discussed.

In February, the special committee for taxation research held a conference with participants from the Riksdagen, the Cabinet Office, the media, taxation authorities, trade unions, the business community etc. The objective of the conference was to discuss the options open to research and the importance of planning to the future design of the tax system. Written contributions and accounts of the discussions were subsequently published in the Foundation's publication series (RJ 1983:2) under the title HUR KLARAR VI 1990? (Eng. = How are we going to cope with 1990?)

In March, a meeting was held in the Riksdagen building on the theme ALKOHOL-POLITIKEN OCH FORSKNINGEN (Eng. = Alcohol policy and research). The special committee on research into health and social problems (now dissolved) sponsored this meeting. Members of the Riksdagen's social and tax sub-committees and representatives of the Cabinet Office, pertinent authorities and organizations participated. The symposium reports RISKEN ATT BLI ALKOHOLIST (Eng. = The risk of becoming an alcoholic) (RJ 1982:1) and ATT FÖRÄNDRA LEVNADSSÄTT (Eng. = Changing your life style) (RJ:1982:3), in addition to introductory remarks made by representatives of the five parliamentary parties, served as the basis for discussions. The alcohol policy programmes of the parties since 1974 and assessments of these programmes made by seven scientists also served as background material. A detailed report on this meeting will be published in the spring of 1984.

In September, the Foundation, in collaboration with the Swedish Council for Research in the Humanities and Social Sciences (HSFR) and the Industrial Council for Social and Economic Studies (SNS), held a symposium called VADAN OCH VARTHÄN? (Eng. = Where do we go from here?) and dealing with Sweden and Sweden's future. Politicians, social critics, trade union representatives and scientists participated. Seminars were held on three themes, viz. FAMILJEN (Eng. = The family), UTVECKLING AV SAMHÄLLSFÖRSTÅELSE (Eng. = Evolution of social awareness) and SAMHÄLLSORGANISATION (Eng. = Society's organization). A report from the symposium is due for publication in the spring of 1984. In conjunction with publication, a discussion will be held between e.g. members of parliament and scientists for the purpose of identifying politically feasible approaches in the ideas contained in the report.

In accordance with its statutes, the Foundation also has the task of promoting contacts with international research programmes. Thus, special travel grants were awarded to enable a number of scientists to present projects and research results at foreign universities or at scientific symposia. There is also a wide-ranging exchange of information with foreign foundations, especially in Europe, with programmes similar to the Tercentenary Foundation's. This kind of information exchange

frequently leads to the establishment of invaluable contacts between individual scientists or groups of scientists.

As before, the Foundation's Board of Directors and/or committees have carried out a number of project visits to various universities and colleges. Detailed discussions were held on project objectives and design. Discussions were also held on the general research problems at universities etc.

The special committees had numerous contacts with representatives for the various disciplines in their field. The object of these contacts was to encourage research and development work in the respective fields. Two reports were published during the year, WOMEN AND MEN IN SWEDISH SOCIETY, a Research Project supported by the bank of Sweden Tercentenary Foundation (RJ 1983:1) and HUR KLARAR VI 1990? Rapport från en konferens om skatter. (Eng. = How are we going to cope with 1990? Report from a conference on taxes, (RJ 1983:2.)

The activities described above are steps in the Foundation's dissemination of information on programmes it supports. But they should also be seen as a way for the Board, experts and Foundation staff to keep up-to-date on research results, points of departure, conditions etc. in projects supported by Foundation grants as the basis for improved assessment of measures undertaken with available research funds. Meetings at which members of parliament and scientists can get together for a mutual exchange of information are of particular merit. Thanks to its unique links to the Riksdagen, the Foundation can serve as a contact between politicians and scientists.

The Bank of Sweden's accounting department audit Foundation accounts throughout the year. An audit was also carried out by the representatives of the Riksdagen's accounting office. In accordance with its statutes, the Foundation will submit its Annual Report to the Riksdagen's accountants.

Summary of New Projects Grants Awarded in 1983

Economic History

Olle Krantz/Lennart Schön, Lund

Sw Cr 270.000 Dnr: 83/144

Crisis and Transformation in the Swedish Economy in the 19th and 20th Centuries

The long-term forces behind the economic transformation process will be studied with a special view to structural crises during the 19th and 20th centuries. The relative sluggishness of the economy or its revitalization capacity in the 19th and 20th centuries when components of the economy and institutional aspects differed, will be central features of the study.

The Tax System and Economic Stagnation

The object of the study will be to examine changes in the total tax burden since 1965 in relation to other economic factors and the most important causes of those changes.

Business Administration

Seasonal Work in the Interior of Northern Sweden

Utilization of the energy in forest and peat, forestry care etc. should create a large number of new jobs in the interior of northern Sweden during the snowless part of the year. The seasonal nature of this employment will cause a number of problems important to government policies for thinly populated communities, the labour market, energy and forestry. However, information on these subjects is limited. The present project will attempt to shed light on these problems.

Economics

Sven-Erik Sjöstrand, Stockholm Sw Cr 172.000

The careers of female B. Econ.'s and B.Sc. (Eng.)'s

The object of the study is to chart career developments for females with baccalaureate degrees in economics and engineering and to identify the factors contributing to that development since women are statistically under-represented in Swedish managerial positions.

Taxation of Capital in Sweden

The taxation of capital in Sweden comprises a combination of different taxes which probably have a major influence on the choice of investment alternatives and saving. The project will describe the present taxation of capital, identify the distribution of the tax burden, design a simplified system for taxation of capital and analyze the effect of such a system.

Assar Lindbeck, Stockholm Sw Cr 150.000 Dnr: 83/197

Intertemporal Aspects of Deficits in the National Budget, Trade Balance and Social Insurance System

The object of the project is to analyze the temporal and inter-generation impact of deficits in the national budget, trade balance and social insurance system on the distribution of income and consumption.

Tax Research

The planned research will deal with central economic and scientific problems concerning budget deficits, the "black" sector of the economy, taxation of capital and distribution taxation.

Cultural Geography

Information Technology, Company Organization and Regional Employment Patterns

The project will examine the way in which new information technology and other circumstances affect company organization and regional employment patterns in three business sectors: banking, insurance and oil. The project is being coordinated with corresponding British research at University College, London.

Dnr: 83/56

Water and Regional Development. Who and what factors govern the Distribution of water in the catchment basin of Motala River?

Developments in recent years have often led to irreconcilable demands, conflicts of interest and disputes regarding the distribution of water resources. Water plays a crucial role in regional development. The project will study the problems from 1800 to 2000.

Sociology/Social Anthropology

Jan Sollenius, Stockholm Sw Cr 70.000 Dnr: 83/2

In the Footsteps of Sweden. A comparative analysis of the development of relevant characteristics of the social systems in Sweden and Hungary

The main themes of the planned empirical comparison of the social systems in Sweden and Hungary will be occupational stratification, the distribution of education, income and wealth, social policy, the welfare system and standard of living indicators.

Kjell Törnblom, Göteborg Sw Cr 50.000 Dnr: 83/20 PL

Justice for the Elderly. Assessments of living conditions

The project will investigate the problems of ageing from the point of view of justice and resource allocation. Intercultural studies will illuminate the problems as a complement to extensive analyses of the elderly in Sweden and comprise explorative, descriptive and hypothesis-testing phases.

Sven Windahl, Lund Sw Cr 30.000 Dnr: 83/63

Young People in the New Media World

The project will conduct an in-depth analysis of the role played by the new media, video films and video games, in conjunction with pop music and TV in the everyday life of different groups of young people.

Jerzy Sarnecki, Stockholm Sw Cr 240.000 Dnr: 83/66

Juvenile Offenders as Adults

The study will serve as a follow-up of material in a 1956 study of juvenile offenders. The object of the study is to shed light on the way in which crimes committed by 11–15-year old boys affected the development of these boys into adults and to describe the present circumstances of these subjects in early middle age.

Ulf Himmelstrand, Uppsala Sw Cr 75.000 Dnr: 83/101

Paradigm Breakthroughs and Inter-disciplinary Aspects of Social Sciences. A two-book project

The object of the study is to utilize the paradigm breakthroughs which occurred in the social sciences in the 1970's in order to increase inter-disciplinary aspects. In a second stage of the project an attempt will be made to create an interdisciplinary – or multidisciplinary – conceptual framework. A third stage will pose a number of questions, dealing with science theory and methodological issues, to Swedish and international sociologists with different specialities.

Lowe Hedman, Uppsala Sw Cr 325.000 Dnr: 83/123

Cable TV on the March. Studies of a new medium

The project will study the introduction of a cable network for radio and TV. Various sub-projects will consider various aspects of this event, including its impact on the existing media and costs.

Per Linell/Karin Aronsson, Linköping Sw Cr 230.000 Dnr: 83/137

Success and Adversity in Dialogues. The ability to exchange complex information in social interplay

The project will examine conversation patterns in various situations in everyday life (negotiations, decision-making, counselling and interviews). Linguistic exchanges in the course of conversational interaction will be analyzed.

Johan Asplund, Lund Sw Cr 208.000 Dnr: 83/152

Elementary Forms in Social Behaviour. A theory on sociality and responsiveness

The object of the project is to frame a simple, general social and psychological theory capable of encompassing a large part of existing social psychology. Fundamental concepts in the theory are "sociality" and "responsiveness".

Tom Burns, Uppsala Sw Cr 275.000 Dnr: 83/178

Wage negotiations in Sweden. Some of the problems incurred by wage drift and solidarity in wage policies as viewed from a structural and process point of view

This project will examine and analyze certain aspects of the structure of and key processes in the Swedish wage negotiation system. The project will also compare wage negotiation systems in other European countries.

Disability and Sexuality

The study will attempt to shed light on the way in which functional disability interacts with social factors to create sexual handicaps affecting the individual's perception of her/his own sexuality and relations with other people.

Statistics

The Development of Statistical Models for the Analysis of Social Systems Data

The project aims at developing a Partial Least Squares method and program for the analysis of models with product terms in the latent variables. No work has yet been done on this kind of model, but such models are the only ones that make any theoretical sense for many applications.

Jan Hoem, Stockholm Sw Cr 75.000 Dnr: 83/170

Women's Life Phases. A study of the education, employment and child-bearing of Swedish women born from 1936–60

The main object of the project is to shed light on the extent to which the increased appearance of women on the labour market has contributed to the decline in the Swedish birth rate in the past 15–20 years.

Political science

Armed Conflicts and Peaceful Resolution of Conflicts

The aim of the project, utilizing the systematic collection of data, is to elucidate the models actually employed in the peaceful solution of armed conflicts and to evaluate the conditions which must be satisfied in attaining lasting agreements.

Göran Hedebro, Stockholm Sw Cr 50.000 Dnr: 83/61 PL

Youths and Work in Massmedia. A study of media contents, circumstances and effects

The object of the project is to describe and analyze the way in which the press covers issues dealing with young people and the labour market. The effects of this coverage on young people's perception of their employment prospects and role in the production process will also be examined.

Nils Elvander, Stockholm Sw Cr 80.000 Dnr 83/155

The organization of Society and Business Revitalization

The project will attempt to identify the changes in the organization of society which may be needed in order to create better conditions for business revitalization and, thus, economic growth.

Håkan Hydén, Lund Sw Cr 335.000 Dnr: 83/159

The Law as an Administrative Instrument

The goal of the project is to investigate the aggregate impact of the factors which affect the application of law in the administrative system. This should yield information on the role of administrative law in the implementation of public commitments.

Olle Törnquist, Uppsala Sw Cr 75.000 Dnr: 83/218

Political Strategy Problems During New Capitalistic Growth

The project raises the issue of the way in which capitalistic growth in developing countries affects the ability to utilize political means for attaining change. It will also deal with the effects of this growth on Swedish aid development programmes.

The Trade Union Press and Culture. The cultural contents of the trade union press from 1870–1980

The emphasis in this project will be on an analysis of the cultural contents of the trade union press from 1870 to 1980. This will provide interesting insights into the Swedish working class' encounter with culture in the past 100 years.

Psychological Treatment and the Classification of Tinnitus

The object of the project is to evaluate and compare psychological methods for measuring tinnitus and to relate these methods to traditional measurement.
